



## **Drip Conversion Rebate Program**

### **Rebate Information/Terms and Conditions**

1. Read the program terms and conditions and the guidelines provided with this package.
2. The rebate only applies to new drip conversions and is not retroactive.
3. The rebate amount is \$0.25 per square foot for up to a maximum of 2,000 square feet. Rebate will not exceed total material costs on receipts. Labor is not included.
4. A list of local EVMWD irrigation supply stores is provided for your reference. EVMWD does not endorse or promote any product, brand, or service.
5. Once you have installed your drip irrigation, please submit a completed, signed Rebate Request form, copy of your original itemized receipts, a minimum of 2 colored photos of before the spray head irrigation was retrofitted, 2 colored photos of after the irrigation was retrofitted and a copy of your current water bill. Please keep a copy for your records.
6. EVMWD will contact you once your paperwork has been reviewed and approved. At this time a check will be sent for the rebate amount.

### **Eligibility:**

1. The retrofit must be completed between 7/1/2023 and 6/30/2024.
2. The property must receive water service from Elsinore Valley Municipal Water District (EVMWD).
3. The Drip Conversion Rebate Program only applies to new drip conversions.

### **Program Terms:**

1. EVMWD customers may only apply and be approved for the Drip Conversion Rebate one time.
2. Properties that receive a rebate for the Turf Replacement program are not eligible for the Drip Conversion rebate.
3. The Drip Conversion Rebate Program only applies to areas that have existing spray head irrigation.
4. Customer must convert entire station/zone.
5. Customer must use a pressure regulator, backflow prevention device and filter with conversion.
6. The completed Rebate Request form must be submitted with copies of your original receipts, 2 before photos of the sprinkler system and 2 after photos of the converted drip irrigation system, and a copy of your current water bill.
7. EVMWD reserves the right to conduct a site visit to confirm the drip system was installed.
