Pool Cover Rebate Program

Rebate Information

- 1. Read the program terms and conditions and the guidelines provided with this package.
- 2. The rebate only applies to new pool covers and does not cover used or secondhand covers.
- 3. The rebate amount is up to \$50 for one pool cover.
- 4. A list of local pool supply stores is provided below for your reference. EVMWD does not endorse or promote any particular product, brand or service.
- 5. Once you have purchased you pool cover please submit a completed, signed Rebate Request form, a copy of your *original itemized* receipt, a photo of your pool, and a copy of your current water bill. Please keep a copy for your records.
- 6. EVMWD will contact you once your paperwork has been reviewed and approved. At this time a check will be sent for the rebate amount.
- 7. A check may take 6-8 weeks to be processed and mailed.


Eligibility

- 1. The pool cover must be purchased between 7/1/2023 and 06/30/2024. Rebate does not apply for secondhand covers.
- 2. Qualifying pool covers include: solar covers, disk covers, and sealed covers impermeable to water.
- 3. The property must receive water service from Elsinore Valley Municipal Water District (EVMWD).
- 4. The Pool Cover Rebate Program only applies to new pool covers (cannot be previously used).
- 5. Pool must be a minimum of 1,000 gallons.

Program Terms

- 1. EVMWD customers may reapply for a Pool Cover Rebate every 2 years.
- 2. The Pool Cover Rebate Program only applies to pool covers that decrease evaporation, such as solar blankets or mechanical covers.
- 3. The completed Rebate Request form must be submitted with a copy of your *original* receipt and a copy of your current water bill.
- 4. EVMWD reserves the right to conduct a site visit to confirm the pool cover is being used.
