## Water Service Rate Changes

On July 1, Elsinore Valley Municipal Water District (EVMWD) will institute a 5% CPI pass through in addition to previously noticed rates. EVMWD works diligently to minimize rate increases; however, some rate adjustments are necessary due to external cost pressures.

### **What is Driving the Rate Change?**

The rate adjustment is primarily due to operational costs associated with providing water services and regulatory compliance. Locally, inflation is at a 40-year high and EVMWD's external costs have increased sharply.



The cost of imported water has increased more than **16%** since 2020 and will continue to increase.



Energy costs have increased by more than **36%**.



Chemical costs have **doubled** since 2021.



Regulatory compliance costs have increased an average of **15%** over the past year.

#### **Rate Assistance Program**

EVMWD is continually working to keep costs as low as possible for our customers while providing clean, reliable water. We are here to assist customers facing financial challenges. 1 EVMWD adopted its current rate structure on June 24, 2021. As part of that action, EVMWD approved authority to increase water rates to account for inflation in accordance with Government Code section 53756, in the event costs exceeded those projected in the cost of service analysis and projected rates. Due to the unforeseen increases in costs to the District, EVMWD is exercising such authority and implementing an additional 5% increase on the water rates based on the Consumer Price Index (CPI), for the Riverside- San Bernardino- Ontario Area, as determined by the U.S. Department of Labor Statistics. Pursuant to Resolution No. 21-06-05 and 21-06-06 and in accordance with Proposition 218, the District is authorized to increase the rates for water service charges by the annual percentage increase as of March of the prior year, in the Consumer Price Index, all Urban Consumers, for the Riverside – San Bernardino – Ontario County Area (as successor to the index for Los Angeles-Orange-Riverside County Area) ("CPI"), as determined by the United States Department of Labor Statistics, in an amount not to exceed 5% in any fiscal year (the "Inflationary Adjustments").

Pursuant to such authority, the District will implement the Pass-Through Adjustments, effective July 1.
